- **Supporting Documents (optional but recommended):** For each question, we ask if you can submit additional documents to confirm the claim. For example, a confirmation letter from your financial auditor verifying that at least 50% of your product or service originates in Ireland.

By preparing these details in advance, you can ensure a smooth and successful submission. Missing or incomplete information may result in further clarification or queries on your application.
